- Memberships are billed one month in advance then monthly thereafter.
- If you drop your membership, before your year is complete, you will not be able to rejoin for a year from the date you dropped your membership. If you do want to rejoin, you will be subject to paying a penalty of up to \$225 fee for each month you didn't pay monthly dues during that dropped period.
- Members can book tee times up to seven days in advance.
- Members only are eligible for range memberships, billed monthly.
- Members can receive handicap service at a nominal fee.
- Charging privileges can be arranged for food & beverage purchases as well as pro shop purchases with a credit card to secure the account.
- Members are eligible to compete in our member only tournaments.
- Members receive 20% off golf shop merchandise

Rules and Regulations

For the benefit of all members and guests, the following rules and regulations govern the use of the facilities at Wekiva Golf Club. These rules are subject to change at any time and without prior notice.

GENERAL

- The hours of operation at Wekiva Golf Club will be established considering the season of year and other circumstances. The hours of operation will be posted at the clubhouse.
- All state and local laws concerning the sale of alcoholic beverages will be strictly enforced
- All food and beverage consumed on the premises must be furnished by Wekiva Golf Club.

COURSE RULES

- All players must register at the pro shop. All fees must be paid in advance.
- Players must start play from the first tee or as directed by pro shop personnel.
- Golf marshals may be on duty to help regulate play and enforce golf cart regulations. Your cooperation is appreciated. Eighteen hole rounds should be completed in four hours and twenty minutes. Nine hole rounds should be completed in two hours and five minutes.
- No more than four players are permitted in a group unless authorized by the pro shop. Singles and twosomes will be paired together when tee times are limited.
- Spectators are at the discretion of the golf shop and must adhere to the dress code and policies and procedures that govern golfers. Spectators who are riding in a golf cart may be charged a cart fee.
- Rain checks will be determined by the amount of holes played. Rain checks will not be issued to players who tee off in inclement weather.

DRESS CODE

• Collared shirts must be worn at all times. Cut-offs, tank tops, tube tops, bathing suits or jeans are not allowed.

GOLF CART RULES

- Golf carts shall not be used without proper assignment and registration in the golf shop.
- Each operator of the golf cart must be 16 years of age or older and have a valid driver's license.
- Only two people and two sets of clubs are permitted per cart.
- Operation of a golf cart is at the risk of the operator. The operator will be held fully responsible for any and all damages resulting from misuse.
- Except on cart paths, do not drive a golf cart within thirty feet of a green or tee box.

COURSE ETIQUETTE

Each player is expected to observe the rules and etiquette of golf while on the course. These are listed in the USGA Rules of Golf. Please show consideration to your fellow golfers while playing at Wekiva Golf Club.

- All players should conduct themselves in a disciplined manner, demonstrating courtesy and sportsmanship at all times. This is the spirit of the game of golf.
- Players should not play until the players in front are out of range.
- Players are required to play at a good pace. <u>It is a group's responsibility to keep up</u> with the group in front. If it loses its position by a hole and is delaying the group behind, please invite the group behind to play through.
- When entering and leaving bunkers, avoid climbing the steepest parts of the bunker. Before leaving a bunker, a player should carefully rake and smooth over all holes and footprints.
- Players should repair ball marks and fill divots with sand that is located on their golf cart.

Cart fees will be charged for each round of golf at the current rate of \$20 + tax for 18 holes and \$12 + tax for 9 holes. *The Family Membership is for one or two adults and up to three dependent family members under the age of 24 still living in the same home. *The junior membership is for youths 10 to 16 years of age and is for walking only at the discretion of the golf shop. *The parent / Child Membership is for one adult and one child under the age of 16. All membership dues are billed at the end of each month, for the upcoming month, plus any charges made the previous month. Payment is due upon receipt. Range memberships can be added to any membership type at any time during the membership period. All rates and information are subject to change without notice.
